I refer to your email received today at 3:25pm. The attached letter states that it appears to the Inquiry that Andrew Crawford has not provided it with a copy of an email sent to Richard Crawford (or its attachment) from the "sent items" of his personal email account. As can be seen from the email of 6 July 2013, Dr Crawford sent this email from his DETI email account ([Andrew.Crawford@detini.gov.uk](mailto:Andrew.Crawford@detini.gov.uk)) and not his personal email account. In previous correspondence my client has explained that he no longer has access to emails to and from his DETI account. Dr Crawford recollected having sent this email upon sight of document WIT-266013 within the materials provided by the Inquiry, and stated that he had done so in his reply to question 53 of Inquiry Notice No 19 of 2018 dated 21 March 2018. I trust this clarifies the position.

**Re: Andrew Crawford**
