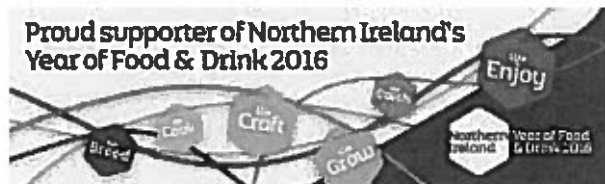

Grateful if you could let me know if any of these dates are suitable and who will be accompanying you to this meeting.

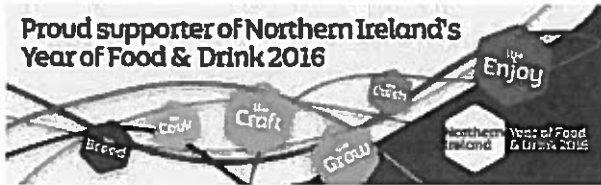
