This will mean that 0-50MWh market will no longer be subject to a price control. This will mean that no small business customers will be able to avail of the regulated tariff.

The main reason for this is that Power NI are no longer a dominant player in the small business market. There is now clear and identifiable competition in the small I&C market and as such the UR must treat all suppliers the same. A price control on Power NI alone is no longer justified as it is no longer dominant.
