There are two issues which immediately come to mind.

&

- 1.&&&&&& There are no grants available for heat recovery to my knowledge, only interest free loans for eligible businesses
- 2.&&&&&& If David Kernohan is viewed essentially as a primary producer ie there is no value being added by processing then it is unlikely that he will be able to access Carbon Trust Interest free loans for energy efficiency (heat recovery systems) However if say there was processing of poultry in any form then he may be eligible but this would need to be clearly defined.
- 3.&&&&&& In addition if perhaps the houses were owned by Moy Park then the operation could be viewed as part of their business operation and again this may be eligible for interest free loans.

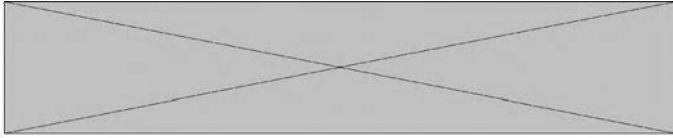
