Hi Bill

Hope you had a good weekend.

Further to my voicemail, we have held a number of meetings with the banks over the course of the last few weeks in order to try and get the operational mechanics for the Scheme in place and agreed pre 'go live'.

One topic that came up in the discussion on Friday was the approach to be taken with existing growers who seek to carry out works that would be along the lines of the following:

1. Existing broiler/breeder houses where a farmer seeks to retrospectively fit windows
2. Installation of biomass boilers
3. The refurbishment of existing sheds
4. The replacement of existing sheds

At one of our meetings, I recall that a reference was made that Moy Park would provide funding assistance where a farmer had to replace plant and equipment (eg water feeders) that had reached the end of their normal lifecycle. However, I would be most grateful if you could provide commentary on what financial assistance (if any) Moy Park currently provides to farmers in each of the 4 listed scenarios.
