Chris,

Sorry to annoy you again about this. One of the installers sent this one of my staff yesterday.

“While it is still in consultation and subject to further change, there have been some further developments. While nothing is concrete as yet, it is better to keep you in the loop. DETI hope to make a final decision by late July/early August, with a proposed implementation in early October. I will keep in weekly contact with Stuart Whitman/Seamus Hughes/Dan Sinton and let you know how this progresses.

The main changes they are expecting to come into force are detailed below,

The 99kW to 199kW tariff is still proposed for October 2015. However, from October 2015, Stuart has also indicated that DETI are proposing to introduce a 2 tiered tariff for all tariff bands, in line with what is in place in GB. Stuart indicated that in the last 7-8 months DETI have overspent on their budget and the reason for this is the operating hours of the boilers in the poultry sector, hence the planned introduction of tier 1 and tier 2 tariffs. This change will only affect new applications after the change comes into force so if any of your clients are considering installing biomass systems we would advise they should move asap to avoid missing out on the best rates from RHI, especially sub 100kW installations.”

This doesn't match what you had been told. We are going to talk to DETI today.
