Some additions in red here. (I've had to save it in a new word file, hope that doesn't cause problems)

* Ironically, given I've added more, I fear it may be too long and too detailed in parts eg on the technicalities of the scheme. The sad lesson of the last few weeks is that detail doesn't win the argument.

* According to the Irish News yesterday, the PAC has a copy of a second email Janette wrote to Arlene (personal email) shortly after the first one, in which some concerns were detailed. This could blow up in FM's face, so need for extreme care in references to whistleblower in speech. Is it too much to hope that members of PAC could advise on alleged second email?

* I think whatever is announced on Monday now needs to be called an inquiry.
