*The DETI Minister has confirmed he is bringing forward legislation to the Assembly to close both RHI schemes to new applications. Subject to approval of the Assembly, the earliest possible date for closure is 00:00 hours on Wednesday 17 February 2016. Any renewable heating systems installed, commissioned and applied for before this will be eligible for RHI payments. Applications will therefore have to be received by midnight Tuesday 16 February 2016.*
