Further to our discussion, this is the approval from DFP and the business case.

The two phases were mentioned in this business case and it was explained that we were starting with a Renewable Heat Incentive(RHI) for non domestic installations and a Renewable Heat Premium Payment (RHPP) for domestic installations but that the RHPP was a forerunner to a RHI for domestic customers (as part of Phase2).

We are now bringing forward part of Phase 2 of the scheme but it is still using the same pot of money i.e the £25m until 2015 from HMT.

Grateful for your view on whether we need to go back to DFP at this stage.
