(DUP - Newry and Armagh) To ask the Minister of Enterprise, Trade and Investment whether her Department plans to reduce the level of Renewable Heat Incentives for new commercial biomass boilers.
[Priority Written]

The non-domestic Renewable Heat Incentive, (RHI) has been in place since November 2012 and supports biogas, biomass, ground heat pumps and solar. Tariffs haven't been reduced and are reviewed annually in line with inflation.

A consultation on phase II of RHI was undertaken last year, (July – October) with a focus on support for a range of new technologies. There are no proposals in the consultation to reduce incentives. Phase II developments will be taken forward in 2015.
