Non Domestic RHI

- We will be holding events for all our staff in both Glasgow and London later this week – with a focus on all that we have achieved so far this year, including the successful implementation of PDS and sustainability.
- We've also achieved 2GW of installed capacity! We have paid out £256m in payments so far on the GB scheme
- Northern Ireland applications continue to increase each month. We have received 170 so far this month alone against an average of 20 – 30 per month ahead of some planned regulation changes.

Central Delivery

- **New Delegated Authority Procedure and Register:** From Friday 16th October a new E-Serve [Procedure](#) covering the request and ongoing management of Delegated Authority (DA) within schemes was launched. This stems from the work undertaken by the *Operational Excellence* forum in developing a new framework for broadening DA within schemes to roles below Band D. The procedure details the steps to be taken by Schemes when a new DA is requested or an existing one is to be amended or rescinded. To support the new process a [Register](#) of all delegations has been created which will assist with ongoing management. Within directorates named individuals are now responsible for ensuring DA is sought and managed in line with the new process. These DA managers are Sarah Methven (RE), Mary Smith (EESP), Steve Blackie (NDRHI) and Gary Henderson (DRHI).
