I had a conversation with Fergal Hegarty from Alternative Heat about the rumored closure of the NIRHI. He confirmed that his source was Seamus Hughes and Stuart Sinclair who work directly for DETI. He explained he has been told that DETI are drastically over budget, they have been refused additional funds from Westminster and that there is a Consultation Paper with Stormont today which is likely to be released on Monday proposing the closure of the NDRHI scheme to new applicant as of March 31st 2016.
Fergal is 100% convinced that the consultation is just "going through the motions" and that the proposed closure is certain
