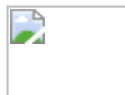

Fiona has a couple of minor presentational amendments for IMP320 Discovery 80 report:

On page 8 reference is made to the difficulty in receiving information which I am aware of. Can this sentence be edited to remove “despite repeated requests” ie full stop after “subsequently”. Page 35 references the potential for CT loan against a couple of the recommendations. Can reference to the CT loan also be included in the sections that detail the recommendations. Eg Rec3 page 30 and Item 1 page 34. Would recommendation 6 also not be eligible for CT support?
