Hi Barry,

I write to you as a distraught constituent and indeed business man. As you are probably well aware Minister Bell has announced that he intends to close the RHI scheme at his earliest convenience.

We have £650K worth of orders taken on this scheme and we have boilers to the value of £400k on transit from suppliers to our manufacturing facility in Omagh which are already paid for and non-refundable.

The immediate future for our 70 staff is under severe treat.

I would appreciate if you could lobby on our behalf to have this scheme extended until at least the end of March to allow us get all current orders completed.

I believe that there is a meeting at 10.30 this morning chaired by Mr Passy McGlone where the DETI Permanent Secretary is to brief CETI on the Renewable Heat Incentive closure announcement.
